Part I

General Introductory Provisions

Preamble

An Act to prohibit the ownership and usage of certain items in order to ensure public safety, and the interests of national security, protection of democracy etc.

Definitions

- (1) **Rosava Nuclear Power Commission** is the organisation created by the Prime Ministerial Decree in the message with id 1037428892295778344.

Part II

Chemical Substances

Abused Drug Substances

- (1) Magic Sugar, made out of equal parts sugar, redstone dust and glowstone dust is a material abused by criminal person(s) in order to carry out criminal activities.
- (2) Any person found carrying Magic Sugar in amounts ranging from 1 to 64 will be charged with Possession of Illegal Abused Drug Substances and may be charged with no more than 1 week of jail time and/or 100 quids in fees.
- (3) Any person found carrying Magic Sugar in quantities above 64, selling or producing Magic Sugar will be charged with Trade of Illegal Abused Drug Substances and may be charged with no more than 2 weeks of jail time and/or 1000 quids in fees, broken only by extraordinary situations where the Trade has affected a group or groups which the compensation may be higher than 1000 quids.

Radioactive Elements

- (1) Radioactive elements pose a threat to the people of Rosava and therefore are disallowed from private ownership without the authorisation from the Rosava Nuclear Power Commission.
- (2) The Rosava Nuclear Power Commission may issue authorisation to locations in which the ownership of radioactive elements is allowed. These locations must comply with regulations released by the RNPC.
- (3) The radioactive elements must not be removed from the locations except for the transfer of the said material between two approved locations in accordance with RNPC regulations.
- (4) The punishments for the breach of RNPC regulations may be disclosed in the regulations themselves.
- (5) Any person found carrying, storing or producing Radioactive Elements outside of an RNPC-approved location will be charged with Illegal Ownership of Radioactive Elements with no more than 2 weeks in jail time or 1000 quids in fees, taking into consideration the amount of radioactive elements as well as the number of persons endangered.

Part III

Weapons

Automatic Weapons

- (1) An Automatic Weapon is a weapon that fires more than one shot in a single action.
- (2) Automatic Weapons are banned from public use and may only be used by the members of organisations created by the Interior and Defense Ministries.
 - (a) The Ministry of Interior may issue ‘Permit to Produce & Sell Automatic Weapons (PSAW)’ to factories to produce automatic weapons which may only be sold to the ministries. The Ministry of Interior may revoke the permit at any time. The factories with the permit will be able to produce and store automatic weapons within factory grounds.
- (3) Any persons found carrying, producing, storing or selling automatic weapons save for the PSAW, will be charged with Illegal Ownership, Production or Trade of Automatic Weapons with no more than 2 weeks in jail time or 2000 quids in fees unless the situation has threatened the national integrity of the republic or endangered the people of Rosava.

Weapons of Explosive Nature

- (1) A weapon of explosive nature is any weapon that is either;
 - (a) By design, causes explosions upon its usage,
 - (b) Designed exclusively to be a part of a procedure in causing an explosion in a combat application tactical or strategic,
 - (c) As a side effect of its design, it can create explosions upon its usage and is used in such a manner.
- (2) Weapons of Explosive Nature are banned from public use and may only be used by the members of organisations created by the Interior and Defense Ministries.
 - (a) The Ministry of Interior may issue ‘Permit to Produce & Sell Weapons of Explosive Nature (PWEN)’ to factories to produce weapons of explosive nature which may only be sold to the ministries. The Ministry of Interior may revoke the permit at any time. The factories with the permit will be able to produce and store weapons of explosive nature within factory grounds.
- (3) Any persons found carrying, producing, storing or selling weapons of explosive nature save for the PWEN, will be charged with Illegal Ownership, Production or Trade of Weapons of Explosive Nature with no more than 4 weeks in jail time or 4000 quids in fees unless the

situation has threatened the national integrity of the republic or endangered the people of Rosava.
